



Resolution no. 1220/2020, of 18 September, authorising the selection committees for recruitment processes to conduct the on-site test or tests in the competitions remotely

FACTUAL AND LEGAL BASIS

ONE. During July and August, various call for competitions for teaching and research staff were published in the corresponding official gazettes.

Specifically, these calls were:

- Resolution 1000/2020, of 2 July, announcing competitions for access to posts for full professors (*Official Gazette of the Spanish Government 10/07/2020*)
- Resolution 1001/2020, of 2 July, announcing competitions for internal promotion to the category of contracted full professor (*Official Gazette of the Catalan Government 10/07/2020*)
- Resolution 1002/2020, of 2 July, announcing public competitions for the recruitment of associate professors (*Official Gazette of the Catalan Government 10/07/2020*)
- Resolution 1118/2020, of 28 July, announcing a public competition for the recruitment of associate professors (*Official Gazette of the Catalan Government 7/8/2020*)
- Resolution 1119/2020, of 28 July, announcing public competitions for the recruitment of assistant professors (*Official Gazette of the Catalan Government 7/8/2020*)
- Resolution 1156/2020, of 30 July, announcing selection processes for the recruitment of assistant professors in the framework of the Serra Húnter Programme (*Official Gazette of the Catalan Government 07/08/2020*) - (PSH 2nd call 2019)
- Resolution 1157/2020, of 30 July, announcing selection processes for the recruitment of associate professors in the framework of the Serra Húnter Programme (*Official Gazette of the Catalan Government 07/08/2020*) - (PSH 2nd call 2019)

TWO. The actions of the committees entrusted with the selection are regulated in the specific conditions for these calls. The specific conditions establish that committee members must be present at some of the tests that make up the selection process.

THREE. As a consequence of the health crisis caused by COVID-19, given that some of the members of these committees do not belong to our university but to universities abroad and that it is important that they participate, the regulations must be adapted in order for the selection process to take place in a manner that guarantees the principles of equality, merit, capacity and public disclosure.

From the above, and by the powers granted to me in the UPC Statutes,

I HEREBY RESOLVE:



ONE. That committee members, with the exception of the secretaries, may choose to participate on site or remotely in those stages of the selection process that the conditions do not foresee are to be conducted remotely.

TWO. That committee members who participate remotely may each sign a copy of the documents that must be signed by all committee members, and that these documents will be as valid if they had been signed in a single copy.

THREE. To publish this resolution in the corresponding official gazettes.

Appeals against this resolution, which exhausts the right of appeal through administrative channels, may be filed with the ordinary courts of Barcelona within two months from the day after the notification of this resolution, in accordance with the provisions of Article 8 of Law 29/1998, of 13 July, which regulates the ordinary courts, without prejudice to the right to optionally file an appeal for reversal before appealing to the ordinary courts with the rector of the UPC, within one month from the day after this notification is received or, if appropriate, from the day after its publication, in accordance with articles 123 and 124 of Law 39/2015, of 1 October, on the Common Administrative Procedures of the Public Administrations.
