Within this timeframe, candidates are expected to present their research, knowledge transfer activities, professional trajectory, and official teaching experience in the mandatory subjects related to the profile of the position. In addition, they shall outline their research and teaching interests and deliver a seminar as specified in the call. Both the presentation and the subsequent discussion will be conducted in English.

Candidates are required to arrive at the venue at least fifteen (15) minutes prior to the scheduled time and must ensure in advance that their presentation file, in PDF format, functions properly so as to avoid any delays. The room will be equipped with a Windows based computer and a projector.

Should a candidate be unable to attend the examination, the committee kindly requests prior notification to the secretary. Please note that remote or online participation will not be permitted according to the call.
