Críteris generals de valoració.- són els establerts a la base 6.1.2. de la resolució 865/2019.

La valoració dels membres del comitè poden ser quantitatives i de barems prefixats o bé deixar el judici dels mèrits específics de cada persona aspirant el criteri, l'experiència i coneixement del camp d'investigació de cada membre del comitè de selecció.

General criteria .-Established in Condition 6.1.2 of Resolution 865/2019.
Specific assessment criteria.- In line with these criteria, the aspects to be considered are those listed below. Committee members may evaluate candidates' merits quantitatively according to a pre-established scale or according to their own criteria, experience and knowledge of the research field.

- Disassociation with the UPC for at least two years: 40 points**
- Research merits: 40 points**
- Quality of research work, citations and dissemination of its results based, among others, on
 - Indexed scientific publications
 - Other scientific publications
 - Books and chapters in books
 - Participation in/direction of relevant research projects and research contracts
 - Distinguished participation in conferences, lectures and seminars given at internationally renowned
- Technology transfer merits: 10 points**
- Quality of the transfer of results
 - Patents and products with registered intellectual property rights
 - Transfer of knowledge to the productive sector
 - Professional experience
- Teaching merits: 35 points**
- Involvement in education
 - University courses taught
 - Supervision of first degree and master's final projects
 - Holding or studying for a teaching qualification
 - Supervision of doctoral theses
 - Quality of teaching work
 - Positive assessments of the candidate's work
 - Original teaching material and publications
 - Innovative teaching projects
 - Management related to teaching
- Other merits: 5 points**
- Project management; leadership qualities
 - Research and teaching awards
 - National and international committees
 - Membership in editorial and scientific association's boards
 - Research stays abroad and international collaborations
- The candidates will therefore obtain a global evaluation with respect to a maximum value of 130 points.
