



Resolution 36/2014, of 17 January 2014, of the Universitat Politècnica de Catalunya, announcing the selection processes for the hiring of teaching and research staff in the framework of the Serra Hünter Programme.

CONSIDERING:

1. Law 1/2003, of 19 February, on universities in Catalonia (LUC); the seventeenth additional provision of Law 5/2012, of 20 March, on fiscal, financial and administrative measures and the establishment of a tax on stays in tourist accommodation; Organic Law 6/2001, of 21 December, on universities (LOU), amended by Law 4/2007, of 12 April; the Statutes of the Universitat Politècnica de Catalunya; the agreement of the Interuniversity Council of Catalonia, of 1 December 2011, in which conditions for Serra Hünter Programme contracts are set out; the governing agreement of the Government of Catalonia, of 3 July 2012, approving the Serra Hünter Programme for contracted teaching staff for the period 2012-2015 and establishing its characteristics; the collaboration agreement, of 5 October 2012, on the development of the Serra Hünter Programme; the collaboration agreement, of 14 December 2012, between the Secretariat for Universities and Research of the Ministry of Economy and Knowledge and public universities in Catalonia, concerning the coordination of advertising and the selection process for recruiting teaching staff under the Serra Hünter Programme; Royal Decree-Law 14/12, of 21 April 2012, outlining urgent measures for restricting public spending on education; and the authorisation of the Secretary for Universities and Research, of 18 December 2013, authorising the public offering in 2011 for the hiring of teaching and research staff at Catalan public universities in the framework of the second stage of the Serra Hünter Programme.
2. The Serra Hünter Programme contracts in the public employment offering for 2011 were reserved for the second stage of the Programme, and this second stage did not begin until 2014, once the agreements with universities were signed and the assessment of the first stage of the Programme were completed. The contracts foreseen in this call do not affect the attainment of university budget stability objectives and other limits imposed in Organic Law 2/2012, of 27 April, on budget stability and financial sustainability. These contracts do not affect the budgetary objectives foreseen in Law 22/2013 on the General State Budget for 2014, and they meet the conditions established in Law 39/2010, of 22 December, on the General State Budget for 2011.
3. The approval, in the Governing Council agreements of 5 November 2012 and 15 March 2013, of the proposal for teaching and research staff contracts within the Serra Hünter Programme; the approval, in the Governing Council agreement of 12 December 2012, which regulates the calls for the provision of places for contracted lecturers with a doctorate under the Serra Hünter Programme; and the approval, through the present resolution of the rector, of the rules governing the public call for employment contracts published on the website of the Universitat Politècnica de Catalunya.

I HEREBY RESOLVE:

One. To convene the public competition for employment contracts for teaching and research staff in the framework of the Serra Hünter Programme. The contracts are listed in the appendix to this announcement and will be governed by the set of rules published on the website <http://www.upc.edu/concursospd>.

Two. That applications must be submitted within 30 calendar days from the date of publication of this resolution in the Official Gazette of the Catalan Government.

Three. To appoint the members of the selection committees listed in the appendix to this call.

This resolution exhausts administrative remedies and may be contested by lodging an application for judicial review with the administrative courts of Barcelona, in accordance with Article 8 of Law 29/1998, which regulates the jurisdiction of the administrative courts, within two months of the date of publication of this resolution, as outlined in Article 46 of said law.

Optionally, interested parties may also, before lodging an application for judicial review with the administrative courts of Barcelona, file an appeal for reconsideration by the body responsible for issuing



the resolution, within one month from the day after the resolution is published, in accordance with articles 116 and 117 of Law 30/1992, of 26 November, on the legal system governing public administrations and common administrative procedures, or any other appeal in defence of the party's interests.
