



Resolution 1623/2017, of 27 July, appointing a new selection committee for the assistant professorship competition in Architectural Design, code UPC-LE-214-215, announced in Resolution 335/2016, of 26 February.

FACTUAL AND LEGAL BASIS

Considering:

That Resolution 335/2016, of 26 February (published in the Official Gazette of the Catalan Government on 4 March 2016), announced the competition for two assistant professor posts in Architectural Design, code UPC-LE-214-215, within the framework of the Serra Húnter Programme.

That the hiring proposal was appealed against and the University's Appeals Committee accepted the appeal and ruled against ratifying the proposal.

That, in Resolution 902/2017, of 5 May, the Rector resolved to accept the claim, not to ratify the hiring proposal, to roll back any actions related to the competition to the moment at which the committee was constituted and to appoint a new committee with new members who have not taken part in the proposal that has not been ratified.

That a new committee was appointed in accordance with Clause 8 of the collaboration agreement, of 14 December 2012, between the Ministry of Business and Knowledge's Secretariat for Universities and Research and Catalan public universities concerning the coordination of advertising and the selection process for recruiting teaching staff under the Serra Húnter Programme.

From the above, and by the powers granted to me in Article 20.1 of Organic Law 6/2001, of 21 December, on Universities, and Article 68 of the current UPC Statutes,

I HEREBY RESOLVE:

ONE. To appoint the members of a new selection committee for the competition for two assistant professor posts in Architectural Design, code UPC-LE-214-215, announced in the Official Gazette of the Catalan Government on 4 March 2016.

TWO. The new selection committee must be constituted within three months of the publication of this resolution in the Official Gazette of the Catalan Government and



evaluate the candidates admitted in accordance with Resolution 879/2016, of 9 May, which makes public the definitive list of admitted and rejected candidates.

FOUR. To publish this resolution in the Official Gazette of the Catalan Government and to inform the members appointed, the candidates admitted, the corresponding bodies of the UPC and the Serra Húnter Programme's directors to the corresponding effects.

Appeals against the resolution, which exhausts the right of appeal through administrative channels, may be filed with the ordinary courts of Barcelona within two months from the day after the notification of this resolution, in accordance with the provisions of Article 8 of Law 29/1998, of 13 July, which regulates the ordinary courts, without prejudice to the right to optionally file a appeal for reversal before appealing to the ordinary courts with the rector of the UPC, within one month from the day after this notification is received or, if appropriate, from the day after its publication, in accordance with articles 123 and 124 of Law 39/2015, of 1 October, on the Common Administrative Procedures of the Public Administrations.
